# F&GP/067/23-24 Apologies for Absence

Apologies were received from Cllr N Clarke. It was **RESOLVED** to accept these apologies.

# F&GP/068/23-24 Declarations of Interest / Dispensation Requests

Cllr C York declared an interest in Groby CIC and in the Village Hall Committee as a Trustee.

# F&GP/069/23-24 To approve the minutes of the Committee meeting held on 3<sup>rd</sup> January 2024

It was **RESOLVED** that the minutes of the Finance & General Purposes Committee meeting held on 3<sup>rd</sup> January 2024 be approved and signed as a true record.

Cllr Beck joined the meeting at 5.10pm

#### F&GP/070/23-24 Clerks Report

i. Hinckley & Bosworth Borough Council Invoice in relation to the May 2023 Elections.

Further to minute reference F&GP/063/23-24 the Clerk advised that a query had been raised with HBBC regarding their invoice for £10,568.95 for the recharge of electoral services for the May 2023 elections. The response from HBBC was read out which explained that the invoice had been verified and a spreadsheet produced to show how the invoice had been calculated. The conclusion from HBBC was that Groby Parish Council had in fact been undercharged.

It was **AGREED** that Groby Parish Council should not accept any further recharges from HBBC due to their initial errors and to **RECOMMEND** to **Full Council** that the payment of £10,568.95 be made.

Cllr Hollick Joined the meeting at 5.20pm

#### F&GP/071/23-24 Budget 2024 – 2025 for Recommendation to Full Council

i. The draft budget (version 4) for the financial year 2024-2025 was included in members' packs and the revisions which had been made following the committee meeting held on 3<sup>rd</sup> January 2024 were discussed and it was AGREED that no further revisions were required.

It was **AGREED to recommend to Full Council** the APPROVAL of the Budget 2024-2025 as presented to the Committee.

The Chair re-ordered the agenda

- ii. Consideration was given to the level of General Reserves required. In accordance with Council's Financial Reserves policy, General Reserves should be targeted to be 3 months of average monthly outgoings. It was NOTED that the predicted year-end General Reserves would fall below this level.
- **iii.** To meet the needs of the budget for 2024-2025 and to provide funding for the predicted year end overspend in 2023-24, mainly brought about by the External Auditor's bill the precept requirement was considered.

It was **AGREED to recommend to Full Council** that a Precept of £299,645.00 be set. With a confirmed tax base of 2640.50 this would equate to an annual precept of £113.48 per band D household. This would see an increase of 26.7% for Groby Parish residents on a Band D property equating to a Tax Band D increase of £23.89 per household per year (or 46 pence per week, 7 pence per day). It was **NOTED** that this would not address the shortfall in General Reserves in line with the Reserves Policy however extra contingencies had been built into the 2024-25 Budget Requirement.

# F& GP/072/23-24 To review the Reserves Policy

The Reserves Policy was reviewed and a revision to the General Reserves clause made.

Further to this revision it was **AGREED to Recommend to Full Council** to approve and adopt the revised policy.

# F&GP/073/23-24 Financial Reports

- i. The Income & Expenditure budget report and EMR report to 28<sup>th</sup> December 2023 were included in members' packs. These were verified and **NOTED**.
- ii. The bank reconciliation and bank statement for November 2023 were included in members' packs. The bank reconciliation was VERIFIED and signed by two members.
